- Public recognition—teacher contributes to building a positive view of career and technical education

CTE Administrator of the Year

- Vision—understands the goals and mission of Career and Technical Education
- Connections—builds CTE connections between students and their next steps (employment or post-secondary education)
- Recognized by teachers and staff as representing excellence in promoting CTE
- Longevity of service—accomplishments have been sustained over time
